- 6. That the school will not open classes under CBSE pattern particularly classIX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individuallygone through the provisions contained in the affiliation & examination byelawsand the circulars issued by the Board from time to time. The school undertakes toabide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.



- That the school will ensure compliance of all statutory requirements like EPF, ESIand Labour Laws etc. with respect to the school and staff of the school.
- That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concernedmunicipal or state authorities from time to time as per the prescribed term.
- That the school will ensure that all required infrastructure is available with theschool before starting classes.
- 11. That the school will ensure that sufficient number of qualified teachers as per theprovisions contained in affiliation bye-laws are available with the school beforestarting classes.
- 12. That the school will follow the provisions related to fee contained in affiliation byelawsand will disclose the details of the fee to the students/parents every yearbefore start of session without resorting to any hidden charges in the heads of thefee.
